SHERIFF'S DEED

This deed is made this <u>19th</u> day of August, 1987, between Thomas H. Duryee, Sheriff of Klamath County, Oregon, grantor, and Western Bank, grantee.

WHEREAS, in a suit in the Circuit Court of the State of Oregon for Klamath County, Oregon, between Western Bank, plaintiff, and Daniel D. Thornton and Juliet E. Thornton, defendants, a judgment and decree was entered on March 18, 1985, for the foreclosure of a mortgage on the real property described below; and
