WARRANTY DEED—SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS, That DANIEL G. BROWN and V. ELOUISE BROWN, husband and wife

for the consideration hereinafter stated to the grantor paid by CAROL E. TONEY and HAZEL V. TONEY

hereinafter called grantees, hereby grants, bargains, sells and conveys unto the said grantees, not as tenants in common but with the right of survivorship, their assigns and the heirs of the survivor of said grantees, all of the following described real property with the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, situated in the County of Klamath, State of Oregon, to-wit:

Lot 11 in Block 3 Country Village, Tract 1203, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Subject to easements and rights of way of record and apparent on the land.

grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$14,100.00
