APPOINTMENT OF SUCCESSOR TRUSTEE

KNOW ALL MEN BY THESE PRESENTS, that whereas the undersigned corporations and national banking associations each individually are the present beneficiaries under various trust deeds covering real property located in the State of Oregon which stand as security for payment of various loans and other debts owed to each of the undersigned, individually, and said trust deeds designate as trustee various qualified persons or parties; and

WHEREAS, the Bank of Corvallis is designated as trustee under certain of the various trust deeds referred to above; and

WHEREAS, the Bank of Corvallis intends to dissolve and terminate its corporate existence;

NOW THEREFORE, in order to provide for the appointment of a successor trustee prior to the dissolution of Bank of Corvallis, each of the undersigned, individually, hereby name, nominate and appoint Old National Bank, a national banking association, and any successor thereof by merger or otherwise, as successor trustee on the following trust deeds and no other: on all trust deeds which currently name Bank of Corvallis as trustee and which cover real property located in the State of Oregon which stand as security for the payment of loans and any other debts owed to the undersigned, individually. BY THESE PRESENTS, the undersigned hereby expressly declare and affirm that the above appointment is limited to trust deeds in which Bank of Corvallis is the present trustee. This instrument is not effective as an appointment of successor trustee as to any trust deed in which any person or entity other than Bank of Corvallis is the trustee.
