KNOW ALL MEN BY THESE PRESENTS, That the undersigned, for the consideration hereinafter stated, has sold and assigned and hereby does grant, bargain, sell, assign and set over unto GEORGE PUCKETT, JR. and JEANETTE PUCKETT, husband and wife

assigns, all of the vendee's right, title and interest in and to that certain contract for the sale of real estate dated February 4, 1986, between The State of Oregon by and through the Director of Veterans' Affairs as seller and ANDREW A.
