NOTICE: Civil penalty amounts are established in Oregon Administrative Rule 812-05-005. Interest will accrue from the date of this order in accordance with ORS 82.010. The interest charge will be waived if the amount due is paid within 60 days.

Builders Board orders imposing civil penalties constitute recordable judgments 10 days following the expiration of the statutory appeals period. If unpaid, such orders may be recorded with County Clerks as liens against property.

APPEAL RIGHTS: You are entitled to judicial review of this order in accordance with ORS Chapter 183. Judicial review may be obtained by filing with the Court of Appeals, Salem, Oregon, a petition for review within 60 days from the date of this order. Tape recordings of administrative hearings are retained 90 days after the date of issuance of a final order. Duplicate tape recordings are available at a cost of \$10 per tape.
