DECREE OF DISSOLUTION
OF MARRIAGE

THIS MATTER coming on to be heard at this time in open Court; Petitioner appearing by affidavit and by and through her attorney, Timothy A. Bailey; Respondent having stipulated to entry of said Decree and waiver of the 90-day waiting period as required by Oregon statute; the Court having ordered that the 90-day waiting period required by Oregon statute be waived on the grounds that the waiver of the waiting period will ease the severe emotional strain upon Petitioner; the Court finding there are irreconcilable differences making continuation of the marriage impossible, and that the Court has jurisdiction of the parties and of the children herein; and that the wife is not now pregnant; and the Court now being fully advised in the premises, now, therefore,

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the marriage contract heretofore existing between Petitioner and Respondent shall be terminated and forever dissolved on the 23rd day of October, 1987; and

1 is awarded the future care, custody and control of the minor
2 children of the parties, namely: Cory James Hammond, a boy,
3 aged 12 years, born May 21, 1975; Neil Richard Hammond, a
4 boy, aged 10 years, born October 13, 1976; and Linsey Renee
5 Hammond, a girl, aged 8 years, born September 10, 1979, subject
6 to the right of Respondent to see and visit said children
7 at reasonable times and places as will not interfere with their
8 health, education and welfare; and

9 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Petitioner
10 shall have judgment against Respondent as and for child support
11 in the sum of \$150 per child or a total of \$450 per month

21 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the
22 Property Settlement Agreement attached to this Decree and made
23 a part hereof is approved and the parties are ordered to comply

25 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that each
26 of the parties herein shall notify the Clerk of the Court

1 in writing of any change in the home or business address of
2 that person within ten (10) days after such change in accordance

5 NOTICE OF INCOME WITHHOLDING -- The support order is enforceable
6 by income withholding under ORS 25.310. Withholding may occur
7 whenever there are arrearages at least equal to the support
8 payment for one month, or whenever the obligated parent requests
9 such withholding. The district attorney, or as appropriate,
10 the Support Enforcement Division of the Department of Justice,
11 will assist you in securing such withholding; and

12 Pursuant to law, the relevant data sheet attached hereto
13 as "Exhibit A" is incorporated by reference and made a part
14 of this Decree.

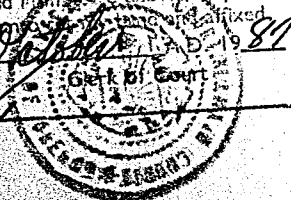
