hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of KLAMATH State of Oregon, described as follows to wit Lot 10 of Block 25, SAVINGS AND EX-CEPTING THEREFROM the Easterly 10 feet of Lot 7, Block 18, and the Westerly 10 feet and the Easterly 10' of Lot 8, 9, and 10, Block 18; and the Easterly 10 feet of the Southerly 25' of Lot 10 of Block 25; as quitclaimed and dedicated for use as public highways to Klamath County by Deed dated April 24, 1931; recorded April 25, 1931, in Book 95 at page 142, DEED Records of Klamath County, Oregon, all in WEST KLAMATH according to the duly recorded plat thereof on file in the office of the County Clerk of Klamath County, Oregon.
