HEREIN AGREE TO ASSUME AND PAY.

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever.

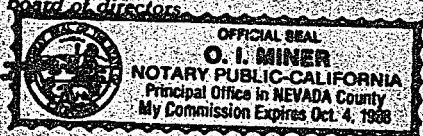
