DECREE OF DISSOLUTION
OF MARRIAGE

THIS MATTER coming on to be heard at this time in open Court; Petitioner appearing by affidavit and by and through her attorney, Timothy A. Bailey; the default of Respondent having heretofore been declared, entered and noted; the Court finding it has jurisdiction of the parties and that Respondent is not now pregnant; and further, the Court finding there are irreconcilable differences making continuation of the marriage impossible, and the Court now being fully advised in the premises, now, therefore,

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the marriage contract heretofore existing between Petitioner and Respondent shall be terminated and forever dissolved on the 6th day of November, 1987; and

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Petitioner is awarded the future care, custody and control of the minor children of the parties, namely: Nickolas Christopher Kappas, a boy, born March 4, 1978, aged 9 years and Michael Charles Kappas, a boy, born July 12, 1971, aged

2 said children at reasonable times and places as will not interfere

4 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Respondent
5 is awarded the future care, custody and control of the minor

26 shall have judgment against Respondent in the sum of \$ 250.00

as and for one-half of Petitioner's attorney fees incurred herein; and

IT IS FURTHER ORDERED, ADJUDGED AND DECREED as follows: NOTICE OF INCOME WITHHOLDING -- The support order is enforceable by income withholding under ORS 25.310. Withholding may occur whenever there are arrearages at least equal to the support payment for one month, or whenever the obligated parent requests such withholding. The district attorney, or as appropriate, the Support Enforcement Division of the Department of Justice, will assist you in securing such withholding; and

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Property Settlement Agreement attached to this Decree and made a part hereof is approved and the parties are ordered to comply with its terms.

Pursuant to law, the relevant data sheet attached hereto as "Exhibit A" is incorporated by reference and made a part of this Decree.

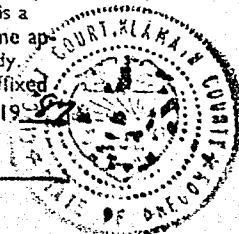
