KNOW ALL MEN BY THESE PRESENTS, That ELMER JOHN ZUMBRUN

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by JEFFREY J. WIMER, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

- Parcel 1: The South 60 feet of the West 60 feet of Lot 4, Block 3, Original Town of Ft. Klamath, Oregon, according to the duly recorded plat thereof.
- Parcel 2: Beginning at the Southeast corner of Lot 4, Block 3; thence West 60 feet; thence North 60 feet; thence East 60 feet to alley; thence South 60 feet to point of beginning, all in Original Town of Fort Klamath, Oregon, according to the duly recorded plat thereof on file and of record in the office of the County Clerk of Klamath County, Oregon.

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 7,500.00.
