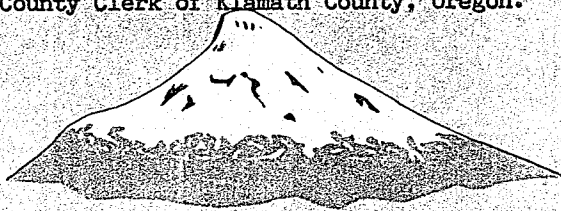


KNOW ALL MEN BY THESE PRESENTS, That GREG M. DEMERS
