LEE M. BURNETT and ELEANOR B. BURNETT, husband and wife

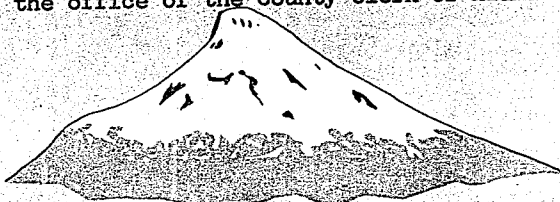
hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by
