

POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that I, EARL W. MACK, do hereby make, constitute and appoint MARILYN M. McCOBB as my trustee and lawful attorney, with power:

1. To demand, forgive, collect and receive any money, property, debts or claims whatsoever, as are now or shall hereafter become due, owing and payable or belonging to me and to give receipts, acquittances or other sufficient discharge for any of the same;
2. To bargain for, buy, exchange, grant options to sell and deal in property and goods of every description;
3. To grant, sell, mortgage, pledge, consign, lease, hypothecate and in any and every manner deal in and with my property, both real and personal;
4. To make and deliver any conveyances, contracts, covenants, and other instruments, undertakings or agreements, either orally or in writing, of whatever kind and nature which my said attorney in her discretion shall deem to be for my best interests;
5. To sign, endorse, sell, discount, deliver and deposit checks, drafts, notes and negotiable instruments and to accept drafts;

If MARILYN M. McCOBB ceases to act as my agent due to her death, disability or resignation, I appoint BEVERLEY A. BRANDT as my attorney in fact and agent. If she shall also cease to act as my agent due to her death, disability or resignation, I appoint BURT MACK as my attorney in fact and agent.

I authorize my said attorney for me and in my name generally to do and perform all and every act and thing whatsoever requisite and necessary to be done in the premises, to conduct, manage and control all my business and my property, wheresoever situated, as it may deem for my best interests, and to execute and acknowledge any and all instruments necessary or proper to carry out the foregoing powers, hereby releasing all third persons from responsibility for her acts and omissions.

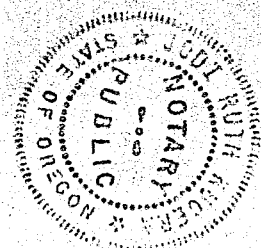
