

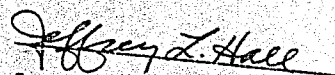

To Whom It May Concern:

- A. The claims listed and identified in attached "Exhibit A" are those claims concerning which this "Notice of Intent to Hold Claims" is being filed. They are listed by their CMC serial numbers and the corresponding names as listed on the BLM microfiche;
