5. Notice to creditors has been published for the period and in the manner prescribed by law. Within 30 days after completion of publication of notice to creditors, an affidavit was filed with the clerk of this Court showing due publication of notice to creditors in the manner and form required by law. More than four months have elapsed since the first publication of notice to creditors. The time for filing or presenting claims has expired, and the estate is now in a condition to be closed.

6. All claims filed or presented against the estate have been allowed by the administrator and paid.

7. All debts of decedent and of the estate and all expenses of administration have been paid, except fees of DAVID S. AULWURM, her attorney.

8. No federal estate tax return has been or will be filed in which a state death tax credit will apply for property located in California, and no California estate tax is due.

9. No federal estate tax return has been made or filed for this estate because the estate was not sufficient to require such a return, and no federal estate tax is due.

10. No California or Federal income taxes are payable by the estate.

11. There will be no further expenses of closing the estate.

12. All assets of the estate are decedent's separate property.

13. Distribution should be ordered as prayed for.
