WARRANTY DEED-SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS, That Rolland K. Williams and Alverta M. Williams, hereinafter called the grantor, for the consideration hereinafter stated to the grantor paid by Rolland K. Williams and Alverta M. Williams and Arlene Frances Reister hereinafter called grantees, hereby grants, bargains, sells and conveys unto the said grantees, not as tenants in common but with the right of survivorship, their assigns and the heirs of the survivor of said grantees, all of the following described real property with the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, situated in the County of _____, State of Oregon, to-wit:

Lot Four Hundred Twenty-Four (424) in Block ONE Hundred One (101) OF Mills Addition to the City OF Klamath Falls, Oregon, according to the duly recorded Plat thereof now on file in the OFFICE of the Clerk of Klamath County, Oregon.

And the grantor above named hereby covenants to and with the above named grantees, their heirs and assigns, that grantor is lawfully seized in fee simple of said premises, that same are free from all encumbrances

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
