KNOW ALL MEN BY THESE PRESENTS, That

FLORENCE G. ROBATCEK

ROBATCEK, ELAINE ACUEFF, DELORES GILCRIST, JACQUELINE METLER, JOHN ROBATCEK, AND WAYNE ROBATCEK, hereinafter called grantees, hereby grants, bargains, sells and conveys unto the said grantees, not as tenants in common but with the right of survivorship, their assigns and the heirs of the survivor of said grantees, all of the following described real property with the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, situated in the County of Klamath, State of Oregon, to-wit:

except those of record and apparent to the land as of the date of this instrument,

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
