NOTICE HEREBY IS GIVEN That the undersigned locators, each a citizen of the United States or one who has declared his intention to become such, have discovered a placer deposit of locatable minerals upon the public domain of the United States which is open to mineral entry and location within the above state, county and mining district; and, in accordance with the laws of the United States and the State of Oregon, have located and hereby do locate a placer claim of 160 acres by posting this notice of location on a post or monument in a conspicuous place inside the boundaries of the claim. This claim is situated in the N.W. 1/4 (quarter section) of Section 12, Township 29 S, Range 6 E, of the Willamette Meridian, either as surveyed by the U.S. Government or protracted if the land is unsurveyed, Protracted
