NOTICE HEREBY IS GIVEN That the undersigned locators, each a citizen of the United States or one who has declared his intention to become such, have discovered a placer deposit of locatable minerals upon the public domain of the United States which is open to mineral entry and location within the above state, county and mining district; and, in accordance with the laws of the United States and the State of Oregon, have located and hereby do locate a placer claim of 160 acres by posting this notice of location on a post or monument in a conspicuous place inside the boundaries of the claim. The claim is named the Red Bear #28 Claim, which is described as follows (fill out one of the two sections below):

thence 1320 feet in a North direction to a post marked No. 6;

thence 1320 feet in a North direction to a post marked No. 7;

thence 1320 feet in a East direction to a post marked No. 8;

thence 1320 feet in a East direction to the post marked No. 1.

This claim is situated in the S.W. 1/4 (quarter section) of Section 24, Township, 29S Range 6E, of the Willamette Meridian, either as surveyed by the U.S. Government or protracted if the land is unsurveyed, protracted
