WISEMAN, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit: Beginning at an iron pin on the East Line of Tract No. 10 in De Witt HOME TRACTS, which lies South 89° 44' West a distance of 1354.6 feet and South 680.3 feet and South 89° 22' West a distance of 30 feet and South a distance of 420 feet from the $\frac{1}{4}$ section corner common to Section 7, Township 39 South, Range 8 East of the Willamette Meridian, and running thence South 89° 22' West a distance of 120 feet to an iron pin; thence South 60 feet to an iron pin; thence North 89° 22' East a distance of 120 feet to the point of beginning, said tract being a portion of the NW $\frac{1}{4}$ of Section 12, Township 39 South, Range 8 East of the Willamette Meridian, in Klamath County, Oregon, known as Tract H.
