Klamath County Engineers Office.

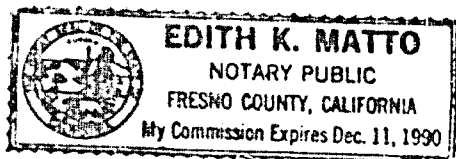
