his heirs, successors and assigns, all of the vendor's right, title and interest in and to that certain contract for the sale of real estate dated January 24, 1979, between James Patrick O'Shea and Jean M. Kahahane

as seller and John Goodman and Sheryl A. Goodman, husband and wife,
