KNOW ALL MEN BY THESE PRESENTS, That George F. Trefcer and Loretta Trefcer, husband and wife

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by ^{Husband and Wife} Robert W. Dougan and Dorothy A. Dougan, ^{his wife}, as Joint Tenants, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Township 40 South, Range 14 East Willamette Meridian
Section 7: NE $\frac{1}{4}$ NW $\frac{1}{4}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$, SE $\frac{1}{4}$ NW $\frac{1}{4}$, SW $\frac{1}{4}$ NW $\frac{1}{4}$, and that portion of the NW $\frac{1}{4}$ SW $\frac{1}{4}$ lying North of Miller Creek.

Township 40 South, Range 13 East of the Willamette Meridian
Section 12: SE $\frac{1}{4}$ NE $\frac{1}{4}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$, that portion of the NE $\frac{1}{4}$ SE $\frac{1}{4}$ lying North of Miller Creek

Subject to easements and rights of way of record and apparent on the land

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$270,000.00.

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.

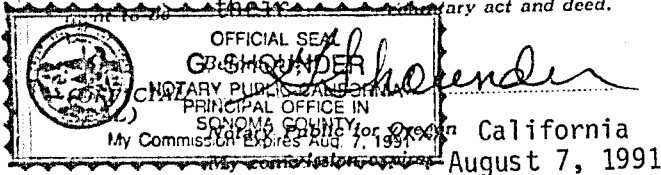
