be placed along and adjacent to the Easterly right-of-way line of Wood River  
Boulevard, as it exists, located along the Westerly boundary of said parcel,  
and also along and adjacent to a roadway, as it exists, extending in a Northeast-  
erly direction from said Wood River Boulevard and located in said parcel.

Situated in the County of Klamath, State of Oregon. It is agreed that  
the Company, its successors and assigns, shall have access to said premises  
for the purposes stated, and shall be responsible for any damage to said premises  
by reason of any negligence on the part of said Company's employees while placing  
and maintaining construction.

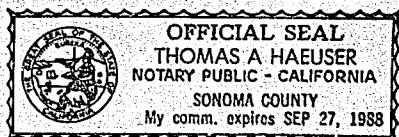
