**KNOW ALL MEN BY THESE PRESENTS, That** JANET SUE WALTON, hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and quitclaim unto

hereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest, in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

**PARCEL 1:** The East 3/4th of Government Lots 17, 24, 25 and the E½ of the W½ of Government Lot 32 in Section 16, Township 36 South, Range 11 East of the Willamette Meridian, EXCEPTING therefrom any portion lying within the O. C. & E. Railroad right of way.

**PARCEL 2:** The West 1/4th of Government Lots 17, 24, 25, and 32, and all of Government Lots 18, 23, 26 and 31 in Section 16, Township 36 South, Range 11 East of the Willamette Meridian; EXCEPTING therefrom any portion lying within the right of way of the O. C. & E. Railroad right of way.

**PARCEL 3:** Government Lots 17, 18, 23, 24, 25, 26, 31 and 32 in Section 17, Township 36 South, Range 11 East of the Willamette Meridian.


