Deed made this <u>3748</u> day of <u>May</u>, 1988, between JERRY O. ANDERSON, of Klamath Falls, Oregon, herein referred to as "Grantor", and SHIELD CREST, INC., an Oregon corporation, of Klamath Falls, Oregon, herein referred to as "Grantee."

1) Grantor is the owner of a tract of land described in "Exhibit A" attached hereto and made a part hereof.

2) Grantee is the owner of a tract of land described in "Exhibit B" attached hereto and made a part hereof.

3) There is on the above-mentioned tract of land of Grantor a well, and it is the intent of the parties by this agreement that they jointly share the use of said well in withdrawing water for the use of the Grantee and Grantor, subject to the provisions hereof.

Therefore, in consideration of the sum of \$10.00, receipt of which is hereby acknowledged, and subject to the conditions set forth in this instrument:

1) Grantor does hereby grant, sell and convey to Grantee one-half ownership of the above-mentioned well and conveys to Grantee the right to take water from said well and to convey such water from the well to Grantee's above-described tract of land by pipe; and

2) Grantor hereby further grants to Grantee an easement to Grantee over Grantor's land for maintenance and repair of said pipe. Said easement is to be appurtenant to the land described in "Exhibit B" and shall be perpetual and run with the ownership of the land described in "Exhibit B."

Page 1 - GRANT OF EASEMENT AND WELL MAINTENANCE AGREEMENT

This conveyance is made on the express condition that Grantor and Grantee both have an equal right to withdraw water from said well for their domestic use for one single-family residence, and that the parties shall each be responsible for maintenance of the pipe line and pump providing water to their respective residents, but shall share equally in the cost of maintaining the well casing and other similar maintenance work.
