easement for the purpose of installing, inspecting,
repairing, maintaining, altering and operating a City sewer
line and all necessary appurtenances in, into, upon, over,
across and under a strip of land described as follows:

together with the right of ingress and egress over grantor's
adjoining lands for the purposes of this easement.

Grantor shall not erect any structures, nor plant any
trees or shrubs, within the easement area which would inhibit
access to said City sewer line or cause damage to it.

The City, its successors or assigns, shall not be liable
to grantor for damage to the above-described premises
occurring incidental to the proper use of this easement.
Provided, however, in the event of damage to premises outside
of and adjacent to the above described parcel(s) caused by
the City, its successors and assigns, the party causing such
damage shall repair same and place said premises in as good
condition as they were immediately prior to such damage.

This document shall be binding upon all subsequent
purchasers of the above-described parcel(s), the City, and
the heirs, successors and assigns, of both.

A strip of land lying in the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 20, T.38S., R.9E., W.M., Klamath County Oregon being a portion of that property described by Volume M82, page 13607 of the official deed records of Klamath County. Said strip of land being more particularly described as follows:

Beginning at a point on the southwesterly right-of-way of Lakeport Boulevard and the northwesterly boundary of the lands of Ivie and Price, said point being North 590.78 feet and East 1066.58 feet from the southwest corner of Section 20, T.38S., R.9E., W.M.; running thence South 20° 36'48" East 48.91 feet; thence South 44°47'16" East 169.88 feet to the southeasterly boundary of the Ivie and Price lands; thence North 75°00'00" East 21.67 feet to the right-of-way of Lakeport Blvd; thence along said right-of-way, North 44°45'46" West 192.94 feet; thence 32.36 feet on a 466.97 foot radius curve right, the long chord of which bears North 42°45'27" West 32.35 feet to the point of beginning.
