ORDER NO. 88-231

I. NATURE OF REQUEST

A public hearing was held on this application on April 26, 1988, being a joint hearing before the Klamath County Planning Commission and the Board of Commissioners.

The request for a Change of Land Use Plan from Forestry to Commercial and Zone Change from Forestry to Highway Commercial was considered pursuant to Articles 47 and 48 of the Land Development Code.

II. NAMES OF THOSE INVOLVED

The applicants, Mr. and Mrs. Gomez, were present. Mrs. Gomez testified in support of this application. Also testifying in support were Ron Tschetter and James Owens. Appearing in opposition was William Peterson.

The Planning Department was represented by Kim Lundahl, Senior Planner. The recording secretary was Karen Burg. David Mannix, Deputy County Counsel, was present.

Members of the Board of Commissioners who sat at this hearing were Roger Hamilton and Jim Rogers.

Members of the Planning Commission who sat at this hearing were Susan Crismon, John Monfore, Ned Livingston, John Kite, Doug Everett, and Fran Gorham.

III. LEGAL DESCRIPTION

Portion of Section 24, Township 31S, Range 7E. Tax Account 3107-24-300. Fifteen acres lying west of Highway 97, north of Silver Lake Highway at Sand Creek Station.

1 IV. RELEVANT FACTS

2 The Klamath County Planning Department file and all contents
3 thereof, Exhibits through R and testimony received, are incorpora-
4 ted in this order as evidence.

5 Notice of this action and an "Exceptions Statement" prepared
6 pursuant to OAR 660, Division 4, was forwarded to the Department
7 of Land Conservation and Development on March 3, 1988. A response
8 dated April 11, 1988, was received and addressed in an addendum
9 submitted by the applicant as Exhibit G.

10 V. RELEVANT APPROVAL CRITERIA

11 Review criteria relating to this application is set out in
12 Land Development Code Article 47 sub 003 and Article 38 sub 003
13 as follows:

14 A. The proposed change is in conformance with all relevant
15 policies of the Klamath County Comprehensive Plan.

16 B. The proposed change is supported by specific studies or
17 other factual information for that change.

18 C. The change of zone is in conformance with the Comprehen-
19 sive Plan, and all other provisions of the Land Development Code.

20 D. The property affected by the change is adequate in size
21 and shape to facilitate those uses that are normally allowed in
22 conjunction with such zoning.

23 E. The property affected by the proposed change is properly
24 related to streets to adequately serve the type of traffic genera-
25 ted by such uses that may be permitted therein.

26 F. The proposed change will have no adverse effect on the
27 appropriate use and development of abutting properties.

28 VI. FINDINGS

The Board of Commissioners and Planning Commission find the
evidence submitted, Exceptions Statement, and testimony offered
demonstrate the approval criteria as set out in Section V, have
been satisfied.

1 VII. CONCLUSIONS

2 This application has satisfied the review criteria in that
 3 correct notice was given, all relevant Comprehensive Plan Policies
 4 and review criteria have been complied with, and an exceptions
 5 statement and addendum were also submitted.

6 VIII. ORDER

7 Therefore, the Board of Commissioners accepts the recommenda-
 8 tion of the Planning Commission, and it is hereby ordered the
 9 submitted exceptions statement and addendum are accepted, and
 10 the request for a Change of Land Use Plan from Forestry to
 11 Commercial and Zone Change from Forestry to Highway Commercial
 12 filed as application CLUP & ZC 1-88 is granted.
