The persons whom I have named herein as my Personal Representative 14 shall have the following powers and authority in addition to those provided. 15 by law: To hold, manage, care for and protect my Estate and the income there-16 of; to operate and manage any and all business belonging to my Estate and any 17 interest therein to the extent of such interest and to continue to operate the 18 same, all at the risk of my Estate, the profits and losses therefrom to inure 19 to or be chargeable to my Estate; to sell exchange; partition, convey and lease 20 the Estate or any part thereof; provided, however, that said Personal Representative shall have no duty or responsibility to sell, change, invest or reinvest any of the assets of my Estate except to the extent that the sale of assets is necessary to pay taxes, claims or expenses of administration, and shall not be held responsible or liable for any loss or depreciation in the value of any property in my Estate; to deposit funds of the Estate in checking and savings accounts in banks and savings and loan associations authorized to do business within the State of Oregon or in any State in which this Will is probated; to borrow money and to encumber or hypothecate by mortgage, trust deed, pledge, security agreement or otherwise all or any part of the Estate as security therefor; to lend the Personal Representative's own funds to the Estate for the protection thereof or for any other purpose.
