

1 I, TRUMAN F. WING, of Klamath County, Oregon, do hereby make and de-
2 clare this to be my Last Will and Testament, hereby revoking all other and
3 former Wills and Codicils by me heretofore made.

4 1.

5 My birthdate is December 20, 1901, and my Social Security Number is
6 543-10-0155. I am married and my wife's name is Margaret H. Wing. I have two
7 children: Dorothy Louise House and Mildred Patricia Cooper, both of whom are
8 of legal age.

9 2.

10 I appoint my said wife, Margaret H. Wing, to be the Executrix of this
11 Will. If my said Wife is unable to assume or complete her duties, I appoint
12 my daughters, Dorothy Louise House and Mildred Patricia Cooper, or either of
13 them, to be such Executrices. If my said Wife and said Daughters are unable
14 to assume or complete her duties, then I appoint my sons-in-law, Ervin Dale
15 House and Alford Cooper, or either of them, to be such Executors. Said per-
16 sons, whether one or more, are sometimes referred to herein as my Personal
17 Representative. I hereby authorize each of said persons to serve without bond.

18 3.

19 I bequeath and devise all of my Estate unto my wife, Margaret H. Wing,
20 if she survives me.

21 4.

22 If my said Wife predeceases me, I bequeath and devise one-half of my
23 Estate unto Dorothy Louise House, if she survives me; and one-half of my Estate
24 unto Mildred Patricia Cooper, if she survives me.

25 5.

26 If my said daughter Dorothy Louise House predeceases me, then I be-
27 queath and devise the one-half share of my Estate that would have passed to
28 said Daughter if she had survived me in equal shares unto the members who sur-
29 vive me of the group composed of all my Grandchildren and my son-in-law Ervin
30 Dale House.

31 If my said daughter Mildred Patricia Cooper predeceases me, then I
32 bequeath and devise the one-half share of my Estate that would have passed to

1 said Daughter if she had survived me in equal shares unto the members who sur-
2 vive me of the group composed of all my Grandchildren and my son-in-law Alford
3 Cooper.

4 6.

5 I specifically state that I have not made this Will in consideration
6 of the execution of a Will by my said Wife and that either of us may change
7 or revoke our Will at any time.

8 7.

9 I direct my Personal Representative to treat as an obligation of my
10 Estate and to pay from the residue of my Estate, without any apportionment
11 thereof, all estate, inheritance, or other death or succession taxes or duties
12 imposed or made payable by reason of my death.

13 8.

14 The persons whom I have named herein as my Personal Representative
15 shall have the following powers and authority in addition to those provided
16 by law: To hold, manage, care for and protect my Estate and the income there-
17 of; to operate and manage any and all business belonging to my Estate and any
18 interest therein to the extent of such interest and to continue to operate the
19 same, all at the risk of my Estate, the profits and losses therefrom to inure
20 to or be chargeable to my Estate; to sell exchange, partition, convey and lease
21 the Estate or any part thereof; provided, however, that said Personal Repre-
22 sentative shall have no duty or responsibility to sell, change, invest or re-
23 invest any of the assets of my Estate except to the extent that the sale of
24 assets is necessary to pay taxes, claims or expenses of administration, and
25 shall not be held responsible or liable for any loss or depreciation in the
26 value of any property in my Estate; to deposit funds of the Estate in checking
27 and savings accounts in banks and savings and loan associations authorized to
28 do business within the State of Oregon or in any State in which this Will is
29 probated; to borrow money and to encumber or hypothecate by mortgage, trust deed,
30 pledge, security agreement or otherwise all or any part of the Estate as se-
31 curity therefor; to lend the Personal Representative's own funds to the Estate
32 for the protection thereof or for any other purpose. The Personal Representative

1 may elect to claim any items which are deductible alternatively for income tax
 2 or inheritance tax or estate tax purposes as the Personal Representative deems
 3 best and such exercise of discretion shall not be subject to question or chal-
 4 lenge by any Beneficiary. The Personal Representative may exercise any and all
 5 of such powers or authority without regard to any prescribed statutory procedure
 6 and without petition, order, citation, hearing, license, notice of sale, auth-
 7 ority or confirmation of any Court.
