That portion of Section 17, T. 41 S, R 11 E, WM described as follows:

Beginning at a 3/4 inch pipe at the southwest corner of the survey for "Lee Mckoen" as shown on Recorded Survey No. 3443, Klamath County Records, Oregon;

thence, N 89°07' W, along the north right of way line of State Line Road, adopted and designated as State of California Route 161, a distance of 83 feet, more or less, to a point which is 30.00 feet left of Engineer's Station 952+57.5, the center of the existing bridge over the U.S. Bureau of Reclamation J-1 Lateral;

thence, continuing along said right of way line, N 89°07' W, 39.59 feet, to a point on the westerly line of the U.S. Bureau of Reclamation easement for said J-1 Lateral;

thence, along said westerly line of said easement N 31°57'19" E, 23.35 feet;

thence, S 89°07' E, parallel with said right of way line measured 20.00 feet at right angles thereto, 122.59 feet, more or less, to a point on the westerly line of said Recorded Survey No. 3443;

thence, along said westerly line, S 31°57'19" W, 23.35 feet to the Point of Beginning.
