ROYSE, husband and wife, herein referred to as Grantors, hereby grant, bargain, sell and convey unto CABELL TERRY HATFIELD and FRED TSCHOPP, JR., co-partners, herein referred to as Grantees, the following described real property, with tenements, hereditaments and appurtenances, to-wit:

The South one-half (S1/2) of Section Twenty-five (25), in Township Thirty (30) South, Range Ten (10) East of the Willamette Meridian, Klamath County, Oregon, consisting of 320 acres.

ALSO: An easement over the following described property: A parcel of land lying in the Southeast corner of the Northeast quarter of Section Twenty-five (25), Township Thirty (30) South, Range Ten (10) East of the Willamette Meridian in Klamath County, Oregon, and beginning at a point on the East line of said Section Twenty-five (25) which is North 86 feet from the Southeast corner of said Northeast one-quarter; thence South on the said East line to the Southeast corner of the said Northeast quarter of Section Twenty-five (25); thence West on the South line of said Northeast quarter a distance of 86 feet; thence Northeasterly in a straight line to the point of beginning.

The true and actual consideration for this transfer is EIGHTY THOUSAND DOLLARS (\$80,000.00).

TO HAVE AND TO HOLD the said premises, with their appurtenances unto the said Grantees, their heirs and assigns forever. And the said Grantors do hereby covenant to and with the said Grantees, that they are the owners in fee simple of said premises; that they are free from all encumbrances excepting reservations of subsurface rights of record, easements and rights-of-way of record, and that they will warrant and defend the same from all lawful claims whatsoever, except as above-stated.
