WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That STANLEY L. LARSON, an estate in fee simple hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by KLAMATH COUNTY, the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

A tract of land being a portion of Lot 1 Block 7 of Altamont Acres, also being in the SW $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 10, Township 39 South, Range 9 E.W.M., Klamath County, Oregon, more particularly described as follows:

Beginning at the Northwest corner of said Lot 1 at the intersection of the Altamont Drive and Onyx Avenue rights-of-way; thence Southerly, along said Altamont Drive right-of-way line, 10.00 feet; thence Northeasterly to a point on the South right-of-way line of Onyx Avenue 60.00 feet Easterly of the Northwest corner of said Lot 1 (point of beginning); thence Westerly 60.00 feet to the point of beginning, containing 300 square feet, more or less.

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever. And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances

Subject to easements and rights of way of record and apparent on the land.

grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
