

## WELL SHARING AGREEMENT WITH EASEMENT

WHEREAS: The parties desire to share the water from a well located on Parcel 1 of NE 1/4 NE 1/4 SE 1/4 of Section 20, T40S R8EWM, Klamath County, Oregon and further described at Land Partition No. LP 22-71, Klamath County, Oregon.

THEREFORE: In consideration of their mutual promises the parties agree as follows:

(1) The water well is located on property owned by Jimmie H. Butler and Colleen Butler, husband and wife, hereinafter referred to as "Butler".

(2) Interest in the well shall be divided into thirds and shall benefit the following parties and property as follows:

(a) 1/3 interest in the well is hereby granted to Butler and shall benefit Parcels 1 and 2 of NE 1/4 NE 1/4 SE 1/4 of Section 20, T40S R8EWM, as further described at Land Partition No. LP 22-71, Klamath County, Oregon.

(b) 1/3 interest in the well is hereby granted to Thomas T. and Patti M. Johnson, husband and wife, hereinafter referred to as "Johnson" and shall benefit Lot 1, Block 2, Cedar Trails Subdivision, Tract 1083, Klamath County, Oregon.

(c) The remaining 1/3 interest in the well is granted to William K. and Debra D. Victor, husband and wife, hereinafter referred to as "Victor" and shall benefit Parcel 3 of NE 1/4 NE 1/4 SE 1/4 of Section 20, T40S R8EWM, further described at LP 22-71, Klamath County, Oregon.

The interest in the well herein granted shall be appurtenant to and run with the owners respective interest in the property benefitted by the well. Only one (1) residence per interest shall be allowed.

The cost of operating the well, including power, maintenance

and repairs shall be shared in the following manner:

(1) Currently, only Butler and Johnson are connected to the well. Butler and Johnson shall share the cost equally, i.e. 1/2 each.

(2) At the time Victor, or his successor, connects to the well, then the cost of operating the well shall be shared 1/3 by each party.

To fulfill the intent of this agreement, the Butlers, their heirs or assigns, grant to Johnsons and Victors a permanent and exclusive easement for the purpose of locating water lines and for ingress to and egress from the well. The easement herein granted to the Johnsons shall be in the location of the existing water lines, as set forth on Exhibit "A". The easement granted to the Victors shall be in a location which will accomplish the intended purpose with a reasonable minimum of interference to the Butler property.


