DECREE OF DISSOLUTION
OF MARRIAGE

THIS MATTER CAME before the Court on December 4, 1987, the Honorable Ralph Holman, Judge pro tem, presiding. Petitioner appeared with her attorney, Harold S. Harding. Respondent appeared with his attorney, Patrick Kittredge. The Court heard testimony and argument. The Court found that irreconcilable differences have caused the irremediable breakdown of the marriage.

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED as follows:

1. Dissolution. The marriage between the parties is dissolved. This decree shall become finally effective to terminate the marriage thirty (30) days after the execution and entry of this decree, or if an appeal is taken, when the suit is determined on appeal, whichever is later.

2. Spousal Support. Husband shall pay spousal support to Wife in the amount of \$200 per month for a total of 24 months beginning with the first 5th of the month following entry of the decree. If either party dies before all the payments are made, the support obligation shall terminate.

Husband shall send the payments to Wife at P.O. Box 544, Albany, OR 97321, or at such other address as she shall designate in writing.

1 3. Personal Property. The parties are awarded the
2 personal property and vehicles in their respective
3 possession, except that Wife is awarded one Charles
4 Russell print and one plate glass mirror which are in
5 Husband's possession.

6 4. Retirement Plans and Insurance. Wife is awarded the
7 Massachusetts Financial IRA. Husband is awarded the
8 Klamath First Federal Keogh Plan. Wife is awarded the
9 MONY life insurance. Husband is awarded the Mutual of
10 Omaha insurance.

11 5. Real Property.

12 a. Wife is awarded the residence, legally
13 described as follows:

14 South half of Lot 8 and all of Lot 9, Block 9,
15 1st Addition to Cypress Villa, City of Klamath
16 Falls, Klamath County, Oregon

17 b. Husband is awarded the shop property, legally
18 described as follows:

19 Lot 49, Block 11, Industrial Addition to the
20 City of Klamath Falls, Klamath County, Oregon

21 Each takes her/his real property subject to the
22 debt which she/he will pay and hold the other harmless
23 upon.

24 6. Debts. Each party will pay and hold the other
25 harmless upon the debts which he/she incurred since
26 August 25, 1982.

27 7. Burial Plots. Wife is awarded both Eternal Hills
28 burial plots.

29 8. Business. Husband is awarded the entire interest in
30 the business Tom's Refrigeration.

31 9. Social Security. Each party is awarded the social
32 security benefits to which she/he is entitled by reason
33 of the length of the marriage.

34 10. Judgment for Attorney Fees and Costs. Wife shall be
35 awarded a judgment against Husband for her attorney
36 fees and/or costs in an amount to be determined under
37 the Rule 68 procedure.

1 11. Notice of Income Withholding. This support order is
2 enforceable by income withholding under Chapter 671,
3 Oregon Laws, Section 4 (ORS 23.175). Withholding may
4 occur whenever there are arrearages at least equal to
5 the support payment for one month, or whenever the
obligated party requests such withholding. The District
Attorney, or, as appropriate, the Support Enforcement
Division of the Department of Justice will assist you
in securing such withholding.


