## SHERIFF'S DEED

THIS DEED made July <u>20th</u>, 1988, between TOM DURYEE, Sheriff of Klamath County, Oregon, hereinafter called Grantor, and ALBERT GRANT and ELEANOR K. GRANT, hereinafter called Grantees,

## W-ITNESSETH:

WHEREAS, in an action in the Circuit Court of the State of Oregon for Klamath County, Oregon, between ALBERT GRANT and ELEANOR K. GRANT, Plaintiffs, and HENRY J. PERRY and MARY F. PERRY, Defendants, a judgment was entered on July 1, 1987, for the foreclosure of a mortgage on the real property described below; and,

WHEREAS, the Court thereafter issued a Writ of Execution, and pursuant thereto on September 11, 1987, all at public auction, subject to redemption, in the manner Provided by law, for the sum of \$206,121.57, to Plaintiffs, ALBERT GRANT and ELEANOR K. GRANT, the highest bidder; and,

WHEREAS, the Sheriff, after receiving from the purchasers the sum of money so bid, duly executed and delivered to the purchasers a Certificate of Sale; and,

WHEREAS, on June 3, 1986, the said HENRY J. PERRY and MARY F. PERRY, as Grantors, issued their deed in lieu of foreclosure to ALBERT GRANT and ELEANOR K. GRANT, as interest, including the equity of redemption, in the real property described herein, which was duly recorded in the 1988, in Book M-88, page 580, that the Grantees herein are delivered said Certificate to the Grantor, and on July 20th, make, execute and deliver to the Plaintiffs ALBERT GRANT and ELEANOR K. GRANT his Sheriff's deed to said property.

NOW, THEREFORE, in consideration of the sum paid for the real property, Grantor does hereby convey to Grantees all the interest the Defendants, HENRY J. PERRY and MARY F.
