KNOW ALL MEN BY THESE PRESENTS, That CHARLES R. DEHLINGER AND BARBARA S.

DEHLINGER dba HOMES TOO

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by

KLAMATH COUNTY

the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

A tract of land being a portion of Lot 8 Block 1 of Third Addition to Altamont Acres, also being in the NE¼NW¼ of Section 10, Township 39 South, Range 9 E.W.M., Klamath County, Oregon, more particularly described as follows:

Beginning at the Southeast corner of Lot 8 at the intersection of the Altamont Drive and Onyx Avenue Rights-of-way; thence Northerly, along said Altamont Drive right-of-way line 10.00 feet; thence Southwesterly to a point on the North right-of-way line of Onyx Avenue 60.00 feet Westerly of the Southeast corner of said Lot 8 (point of beginning); thence Easterly 60.00 feet to the point of beginning, containing 300 square feet more or less.

Subject to easements and rights of way of record and apparent on the land.

grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
