1. Venue is properly laid in this court and no other
court in this state has acquired jurisdiction in this matter.

2. Notices as required by ORS 126.007 and 126.187 have
been given to the persons entitled thereto. The time for filing
objections has expired and no objections have been filed herein.

3. CLARENCE WALTON REEVE is incapacitated and an
appointment of a guardian is necessary as a means of providing
continuing care and supervision of his person. WALTON REEVE is a
qualified and suitable person to act as guardian.

4. CLARENCE WALTON REEVE owns property and receives
income which is in need of protection because he cannot effec-
tively manage personally owned property without assistance

5. WALTON REEVE has priority for appointment as conservator herein and is a qualified and suitable person to act as guardian and conservator and is willing to serve.

NOW THEREFORE, it is hereby ORDERED:

1. That WALTON REEVE be and he hereby is appointed guardian and conservator for CLARENCE WALTON REEVE.

2. Letters of guardian and conservatorship shall issue to him forthwith *upon filing a bond in the amount of \$100,000. 07/1*
