Mortigage Extension Agreement made as of this 29 day ____, 1988, by and between McVAY FARMS, a general partnership comprised of Ronald C. McVay and Barbara A. McVay, and RONALD C. McVAY and BARBARA A. McVAY, in their individual capacities (hereinafter collectively referred to as "Mortgagors"), and UNITED STATES NATIONAL BANK OF OREGON (hereinafter "Bank"), a national banking association,

WITNESSETH:

WHEREAS, Mortgagors pursuant to that certain mortgage dated April 3, 1987, and recorded on April 9, 1987, in Volume M87 at Page 5948 of the mortgage records of Klamath County, Oregon, and rerecorded on June 5, 1987, in Volume M87 at Page 9728 of said records (hereinafter the "Mortgage") have mortgaged unto Bank the real property legally described in the Mortgage in order to secure repayment of certain indebtedness described in the Mortgage;

WHEREAS, the indebtedness described in the Mortgage has been renewed into two promissory notes, one in the amount of \$ 675,334.42 with interest at 10.5 percent per annum payable by McVay Farms (the "McVay Note") and one in the amount of \$_426,221.45 with interest at 10.5 percent per annum payable by Shasta View Produce, Inc., an Oregon corporation (the "Shasta Note"); and

WHEREAS, Mortgagors and Bank desire to amend the terms of the Mortgage to reflect said renewal;

Now, THEREFORE, it is hereby acknowledged and agreed that the Mortgage secures payment of all sums owing under the McVay Note and the Shasta Note. The maturity date for the McVay Note and the Shasta Note when all unpaid principal and accrued interest shall be due and payable is June 30, 1993.

All terms and provisions of the Mortgage not expressly modified herein shall remain in full force and effect.
