#### NATURE OF REQUEST I.

A public hearing was held on this application on July 25, 1988, being a joint hearing before the Klamath County Planning Commission and the Board of County Commissioners.

The request for a Change of Land Use Plan from Forestry to Agriculture and Zone Change from Forestry Range to Exclusive Farm Use-Cropland/Grazing was considered pursuant to Articles 47 and 48 of the Land Development Code.

The applicant, Ron Edwards, was present and offered testimony in support of his application. No one offered testimony, written or oral, in opposition to this application. - D. The property affected by the change is adequate in size and shape to facilitate those uses that are normally allowed in conjunction with such zoning.
- E. The property affected by the proposed change is properly related to streets to adequately serve the type of traffic generated by such uses that may be permitted therein.
- F. The proposed change will have no adverse effect on the appropriate use and development of abutting properties.
