Reference is made to that certain trust deed made by ROBERT H. BERMAN, as grantor, to TRANSAMERICA TITLE INSURANCE COMPANY, a California Corporation, as trustee, in favor of WELLS FARGO REALTY SERVICES, INC., a California Corporation, Trustee, as beneficiary, dated April 9, 1979, recorded July 25, 1979, in the mortgage records of Klamath County, Oregon, in book No. M-72 at page 17751, covering the following described real property situated in said county and state, to-wit: Lot 1, Block 42, Tract No. 1184, OREGON SHORES UNIT 22, FIRST ADDITION, in the County of Klamath, State of Oregon.
Both the beneficiary and the trustee have elected to sell the said real property, to satisfy the obligations secured by said trust deed and a notice of default has been recorded pursuant to Oregon Revised Statutes 86.735(3); the default for which the foreclosure is made is grantor's failure to pay when due the following sums: Monthly installments of principal and interest due for the months of May, June, July, August, September, October, November, and December of 1986, and January and February of 1987 in the amounts of \$54.10 each; and subsequent installments of like amounts; Subsequent amounts for assessments due under the terms and provisions of the Note and Trust Deed.
By reason of said default the beneficiary has declared all sums owing on the obligation secured by said trust deed immediately due and payable, said sums being the following, to-wit: \$3,182.81 plus interest and late charges thereon from April 22, 1986, at the rate of EIGHT AND ONE HALF (8 1/2) PER CENT per annum until paid and all sums expended by the beneficiary pursuant to the terms and provisions of the Note and Trust Deed.
