 sewer line or cause damage to it.

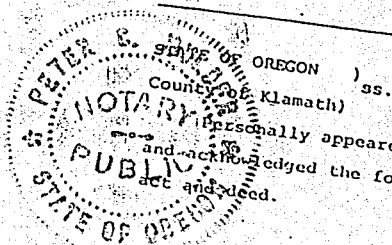
The City, its successors or assigns, shall not be liable to grantor
