DECLARATION OF COVENANTS, CONDITIONS & RESTRICTIONS
OF
BLEY-WAS HEIGHTS & FIRST ADDITION TO
BLEY-WAS HEIGHTS SUBDIVISION

WHEREAS, the 1987 Amendment No. 2 to the Declaration of Covenants, Conditions and Restrictions of Bley-Was Heights and First Addition to Bley-Was Heights Subdivision may have created confusion and/or contradiction with existing county ordinances; and

WHEREAS, it is the desire of this corporation to remove any doubt or confusion that may have transpired because of said Second Amendment;

NOW THEREFORE, the following is a modification of said Declaration and the subsequent amendments thereto, where applicable:

1. Section 6 of Article II is herewith amended to read as follows:

No structure of a temporary nature, trailer, basement, tent, shop, garage, barn or other outbuildings shall be used on any parcel or lot at any time as a residence, either temporarily or permanently. Notwithstanding, nothing herein shall be deemed a prohibition against the seasonal use of a recreational vehicle for limited residential purposes, provided that such use in no manner conflicts with or is in violation of any existing ordinance, law or other such governmental regulation.

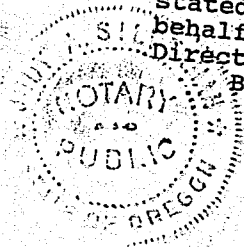

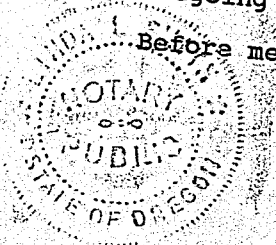
