hereinafter called grantees, hereby grants, bargains, sells and conveys unto the said grantees, not as tenants in common but with the right of survivorship, their assigns and the heirs of the survivor of said grantees, all of the following described real property with the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, situated in the County of Klamath, State of Oregon, to-wit:

Lot 1 Block 5, Oregon Shores Subdivision, Tract #1053, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Lot 26 of Block 36 in Tract 1184 Oregon Shores Unit 2 1st Addition, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
