## NOTICE HEREBY IS GIVEN THAT:

1. MICKI MARY ATKINS, DBA Wicklines Auto & Tire Shop, hereinafter called the claimant, pursuant to the provisions of ORS 87.152, claims and has a possessory lien upon the following described articles of property, hereinafter called chattels, Contents of barn excluding front workshop.

for claimant's just and reasonable charges for storage which claimant has furnished in storing said chattels at the request of and for the owner or lawful possessor thereof, hereinafter called the lien debtor.

2. At the time said request was made the name of the lawful possessor of said chattels was Wicklines Auto and Tire Shop and his last known address on the date hereof is 6850 South Sixth Street, Klamath Falls. at said time the name of the owner or reputed owner of said chattels was WICKLINES AUTO AND TIRE SHOP and, if an individual, his last known address on the date hereof is ; however, if said owner or reputed owner is a corporation, the name of its registered agent and the address of its registered office as of the date of this notice as shown by the records of the Corporation Commissioner of the State of Oregon (ORS 57.065, 57.075) is

3. Said chattels were left with claimant to be stored in Klamath County, Oregon on April 16, 1988, 19, which was the date on which claimant obtained possession thereof; claimant has continuously stored said chattels since said date and is still continuing to do so; at all times hereinafter mentioned, possession of said chattels has been and is now retained by claimant; more than sixty days have elapsed since claimant's lien attached to said chattels. The amount of the agreed charge for said storage is \$10.00 per day, a total up to the date hereof of \$1,780.00.

(b) If there was no agreement relative to said charge, then \$10.00 per day is a reasonable charge for said storage, a total up to this date of \$1,780.00.

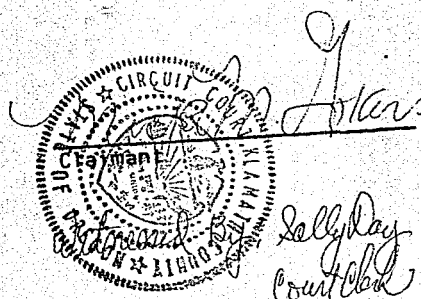
(c) The amount of said lien is increasing at the rate just mentioned, dependent on the length of time hereafter during which continued storage is furnished by claimant.

(d) No part of said total has been paid except the sum of \$-0-; the amount now due on claimant's lien is \$1,780.00.

(e) The said lien debtor either knows or should reasonably know that the said charges are due.
