2. To ask, demand, sue for, recover, collect, receive, hold, vote and possess all sums of money, bank accounts, debts, dues, bonds, notes, checks, drafts, money orders, accounts, deposits, annuities, pension and retirement benefits, insurance benefits and proceeds, documents of title, stock and bond certificates, choses in action and have, use and take all lawful steps and procedures in my name for the collection and recovery of the same and to make, execute and deliver in my name all endorsements, releases, receipts or other discharges of the same, and to pay any and all bills, accounts, claims and demands payable by me.

3. To buy, sell, lease, rent, exchange, convey, mortgage, improve, repair, maintain, manage and insure all real property or business which I now or in the future own.

4. To sign, endorse, execute, acknowledge, deliver, receive and possess any written instruments as are necessary in the exercise of the rights and powers herein granted.

5. I do further authorize and empower my attorney in fact as follows:

6. The enumeration of specific acts, rights and powers shall not be construed as limiting or restricting this general power of attorney. I grant to my attorney in fact full power and authority to do and perform every act and thing requisite, necessary and proper in furtherance of the right and powers granted as fully as I might do if personally present with full power of substitution or revocation and do hereby ratify all things lawfully done by my attorney in fact.

7. This power of attorney shall commence on the 13th day of Oct. 19 88 and expire on the 1st day of Nov. 19 88 unless sooner terminated by written notice.

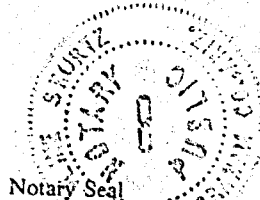
