- (c) An easement 30 feet wide extending East from district's West Side Irrigation Canal along the North side of the South section line of Section 23, Township 40 S., R. 13 E.W.M., to the West boundary of Section 24, Township 40 S., R. 13 E.W.M., Klamath County, Oregon.
