WHEREAS, said larger parcel was divided upon an involuntary disposition, and

WHEREAS, LANGELL VALLEY IRRIGATION DISTRICT, a municipal corpora-tion in Klamath County, Oregon, herein called "district", does not have an irrigation ditch adjacent to and able to serve directly the above-described real property belonging to grantor.

NOW, THEREFORE, for and in consideration of the mutual covenants and agreements hereinafter contained, it is agreed as follows:

(1) Grantor hereby conveys, assigns and transfers to district all of her right, title and interest in and to the following-described easements, all situated in Section 23, Township 40 S., R. 13 E.W.M., Klamath County, Oregon, to-wit:

An easement 30 feet wide extending East from district's West Side Irrigation Canal along the district's west blue intigation canal along the southerly side of the East-West center line of Section 23, Township 40 S., R. 13 E.W.M., to Township 40 S. the West boundary of Section 24, Township 40 S.,

- An easement 30 feet wide, the center line of which extends East from district's West Side (b) Irrigation Canal along a line located 660 feet South of and parallel to the East-West center line of Section 23, Township 40 S., R. 13 E.W.M., to the West boundary of Section 24, Township 40 S., R. 13 E.W.M.
- (c) An easement 30 feet wide extending East from district's West Side Irrigation Canal along the North side of the South section line of Section 23, Township 40 S., R. 15 E.W.M., to the West boundary of Section 24, Township 40 S., R. 15 E.W.M.

TOGETHER WITH the right of ingress and egress for the purposes hereinafter mentioned.

(2) In consideration therefor district agrees to give grantor a \$500.00 credit against the 1988-89 assessment for irrigation water to be used on grantor's property hereinabove described.

(3) District will assume control of and will maintain the existing ditches upon said easements for irrigating the above-described property of grantor and other properties served by district lying below the district's West Side Canal.
