RIGHT-OF-WAY EASEMENT (Corporate)

that portion of land located in the Northeast Quarter of the Southeast Quarter of Section 3, Township 39 South, Range 9 East, Willamette Meridian.

The location and course of said right-of-way is approximately as shown on the sketch attached as Exhibit "A" and by this reference made a part hereof.

Said right-of-way to be 20 feet wide, 10 feet each side of centerline.

"Together with the right of ingress and egress over the adjacent lands of the Grantor for the purpose of constructing, reconstructing, stringing new wires on, maintaining and removing such line and appurtenances, and exercising other rights hereby granted.
