

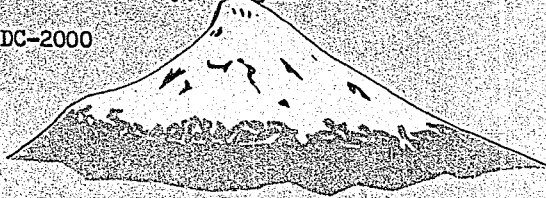
KNOW ALL MEN BY THESE PRESENTS, That BERTRAN J. THICKETT & LORI ANN THICKETT,
